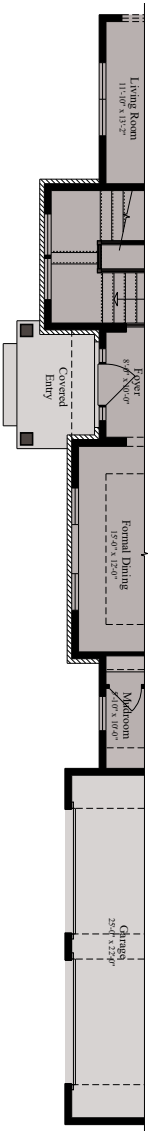


MAIN LEVEL ELEVATION "A"

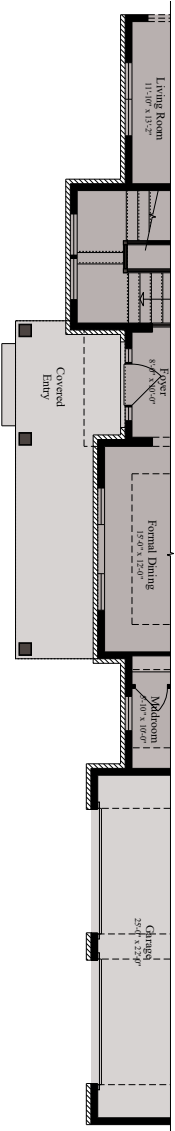

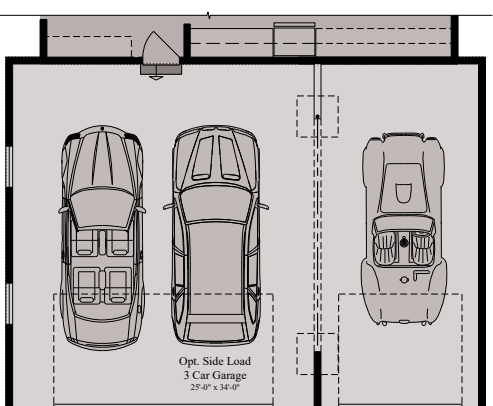

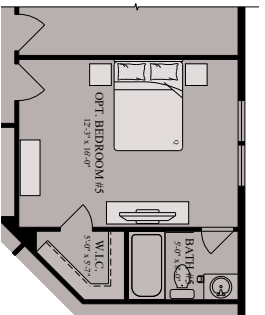

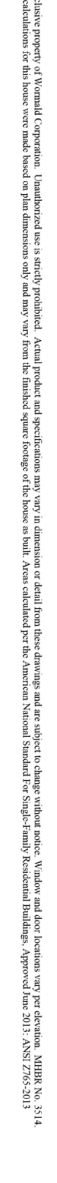

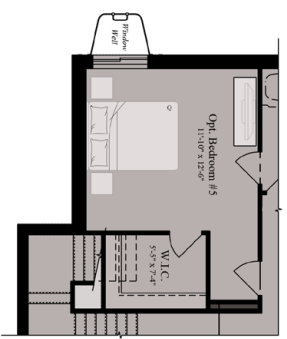

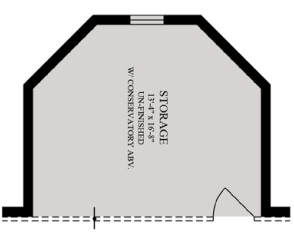

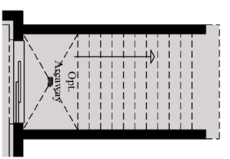
