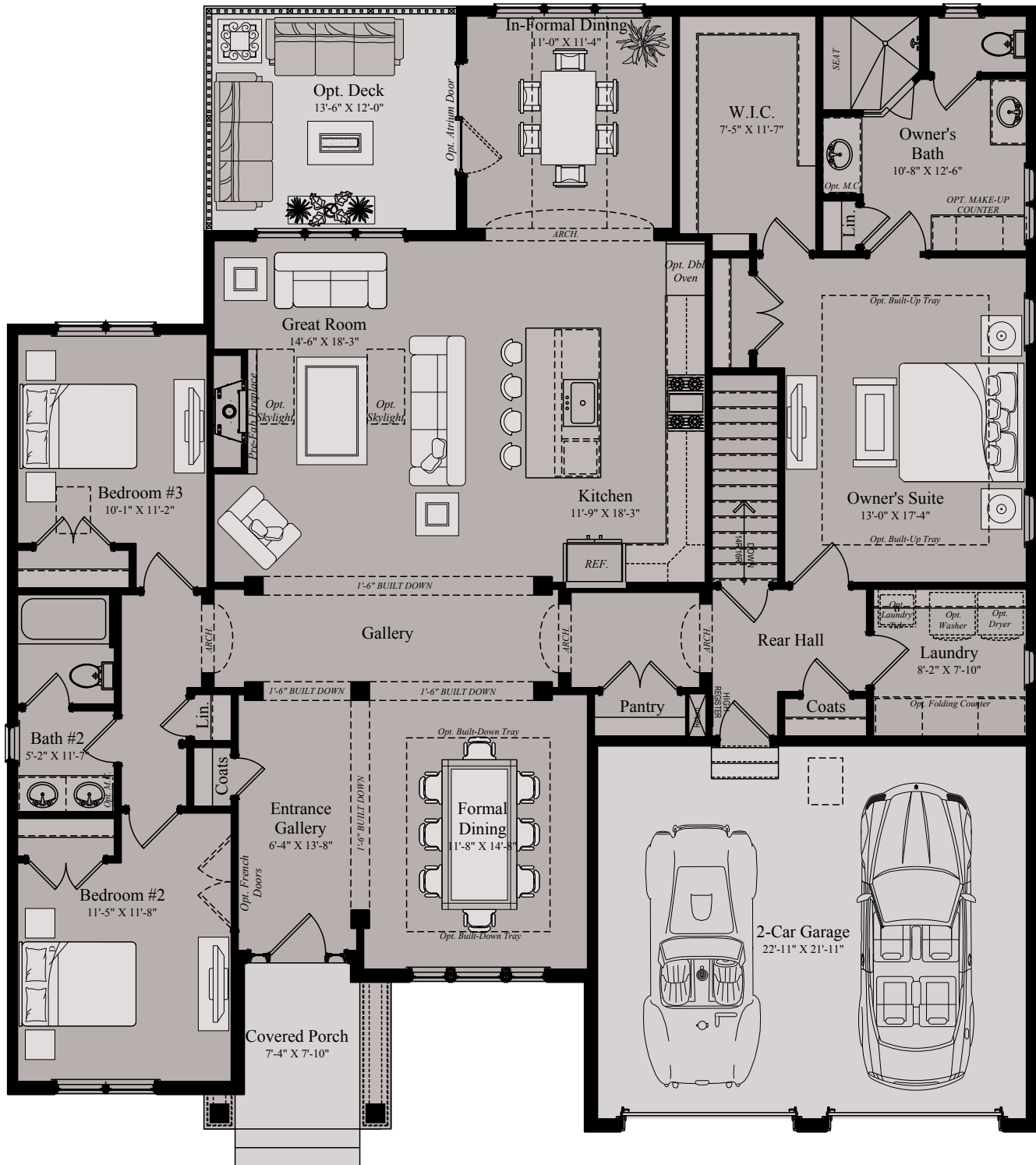

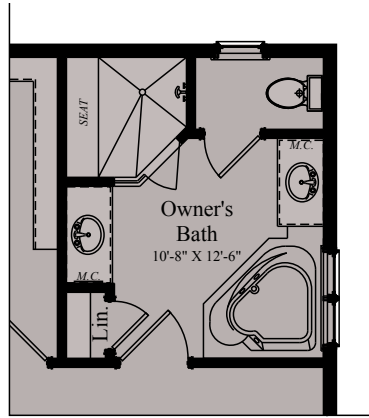

ELEVATION A**



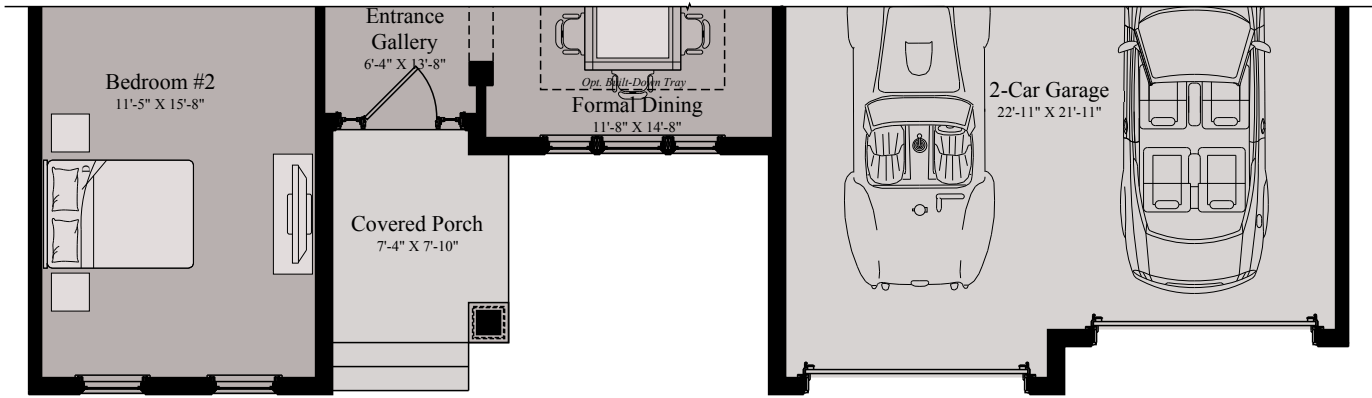

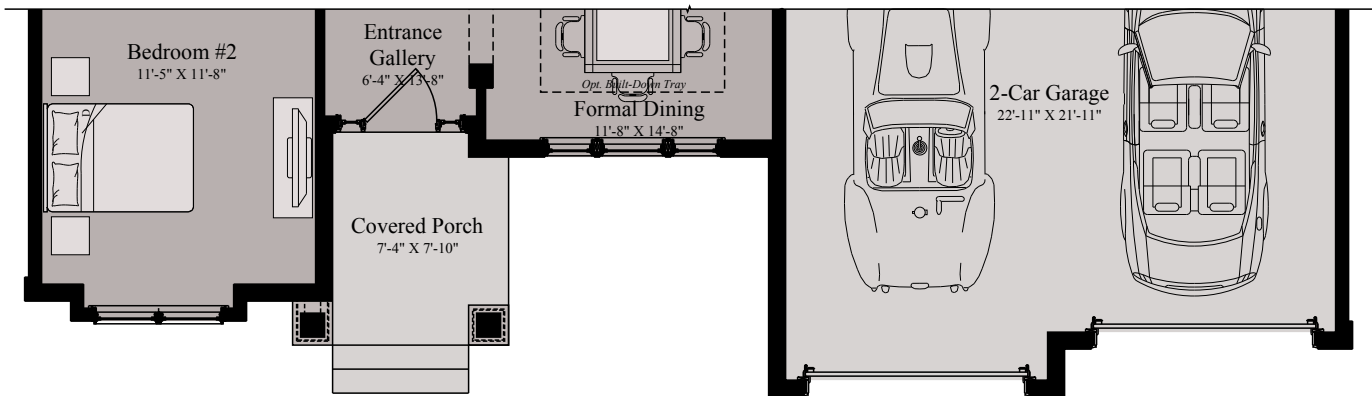




**PARTIAL MAIN LEVEL - OPT.

SUNROOM W/ 5' EXTENSION**



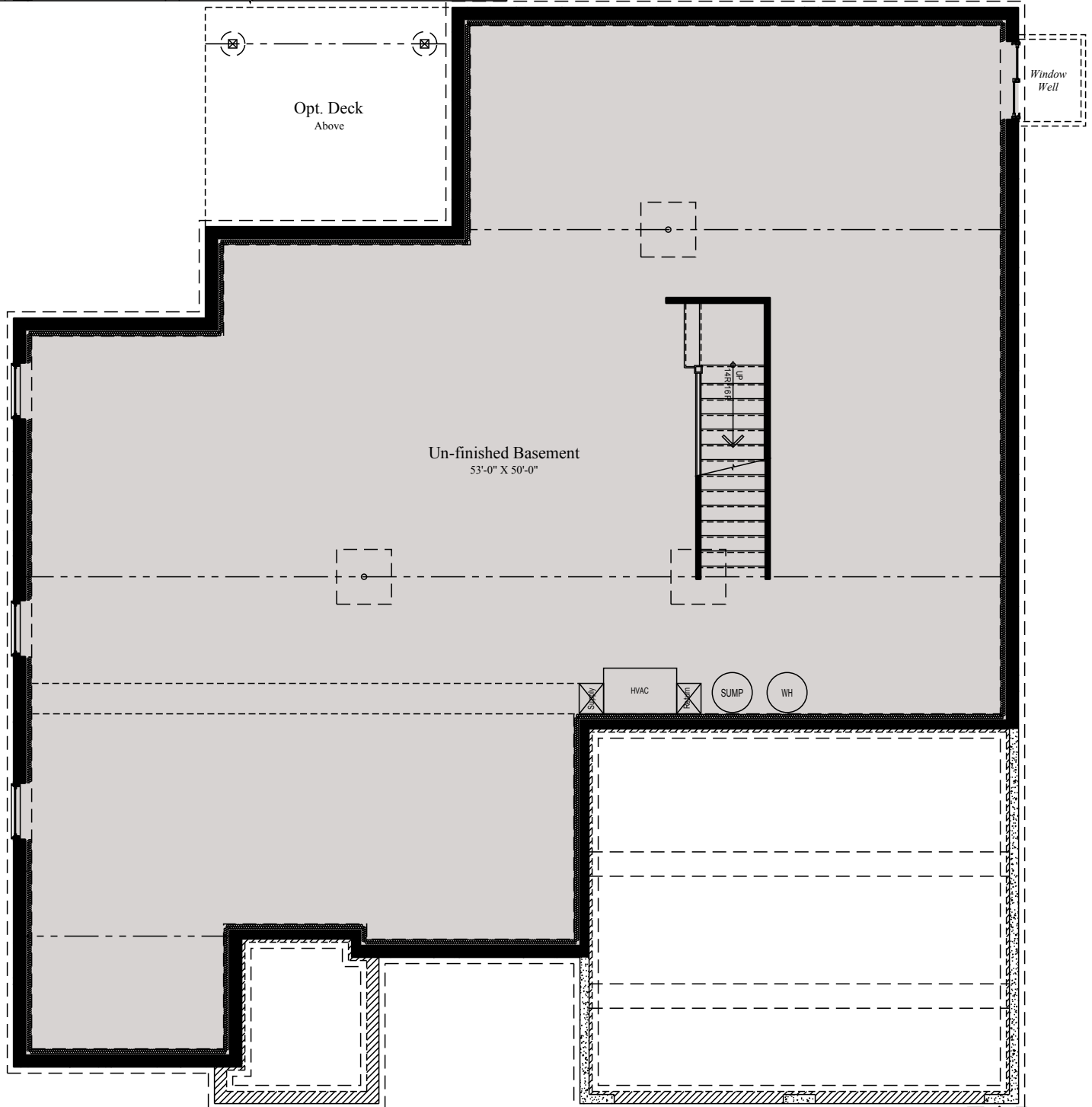
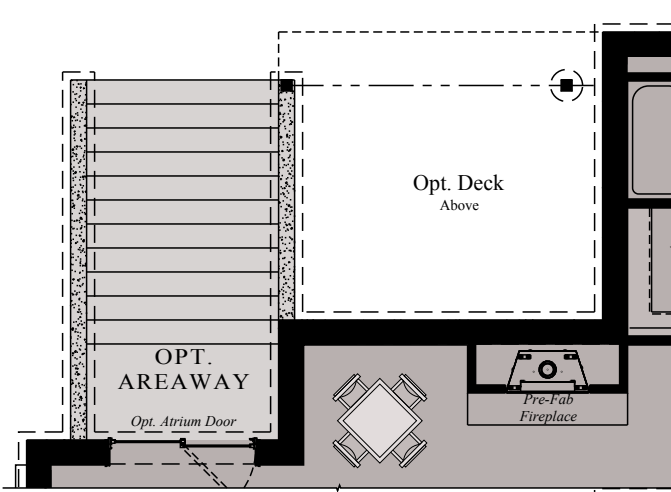

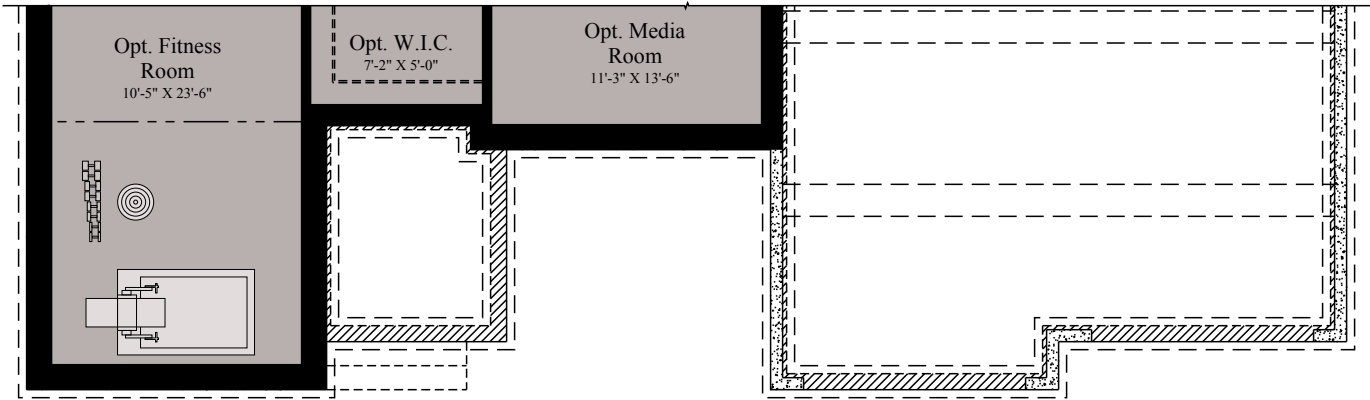
**OPT. FINISHED LOWER LEVEL
IN-GROUND CONDITION - ELEVATION A**



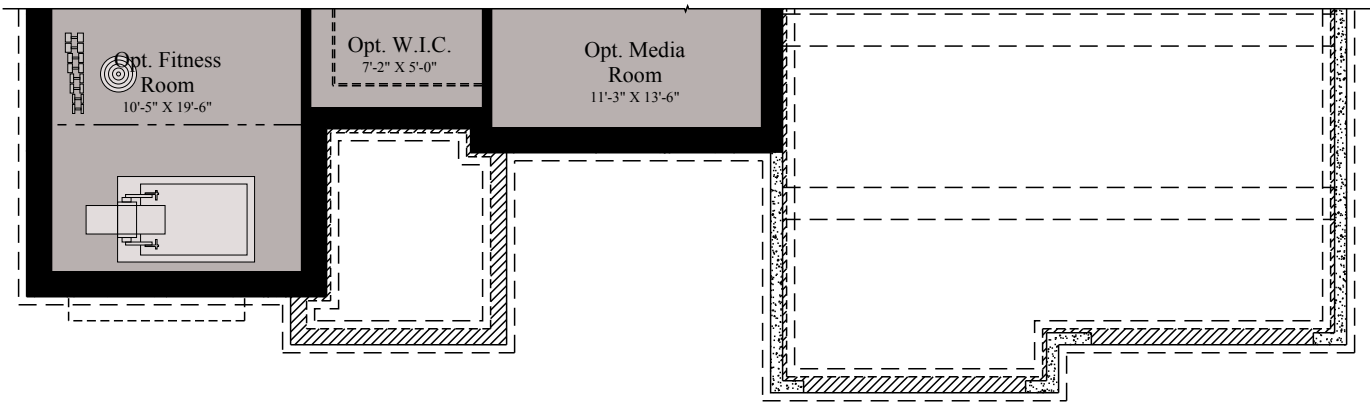

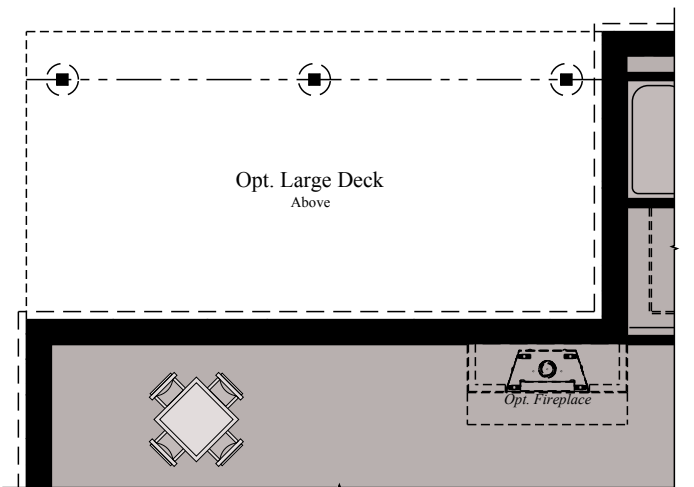
**PARTIAL LOWER LEVEL -

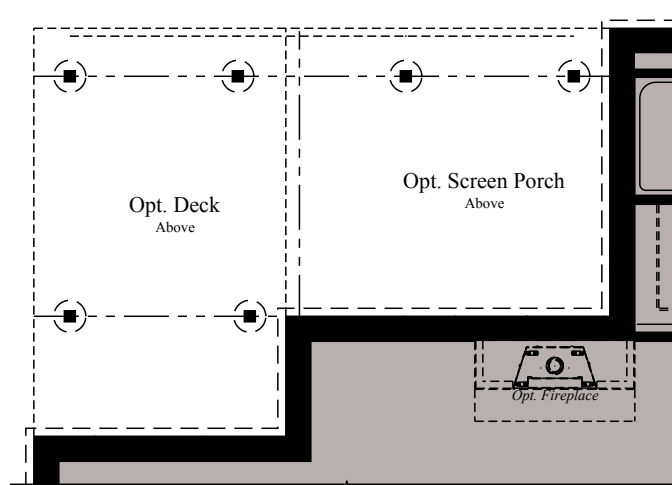

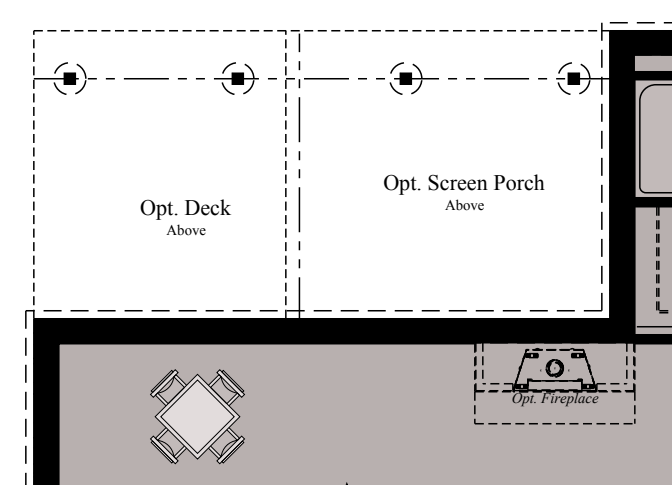

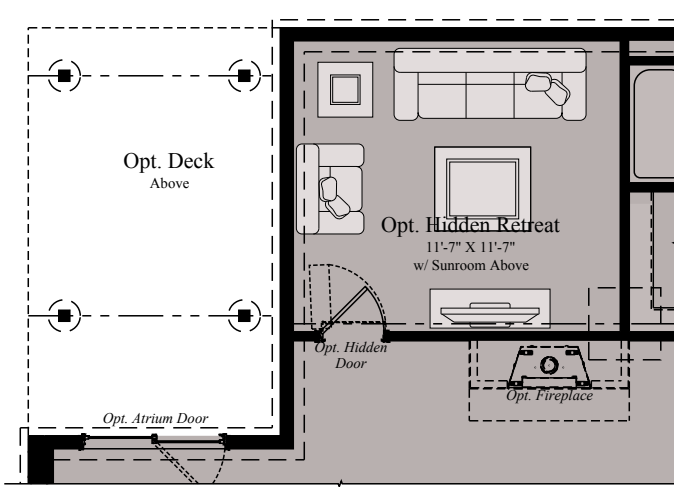


PARTIAL LOWER LEVEL -

OPTIONAL SCREENED PORCH

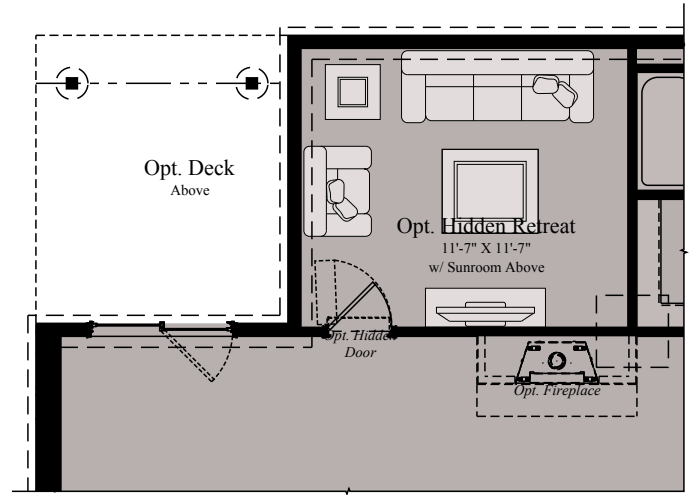

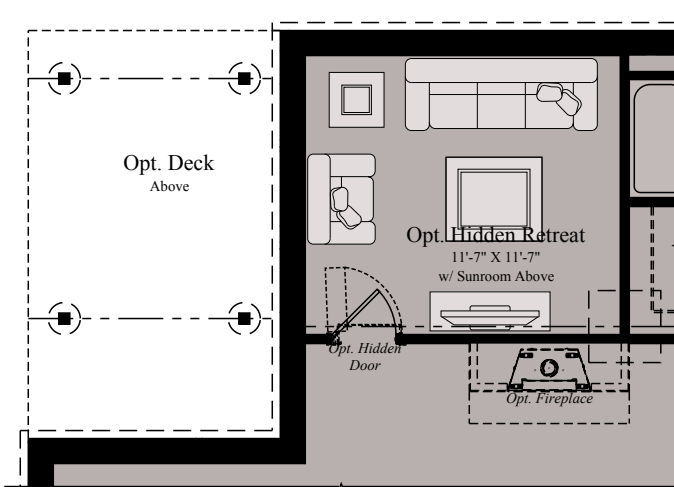

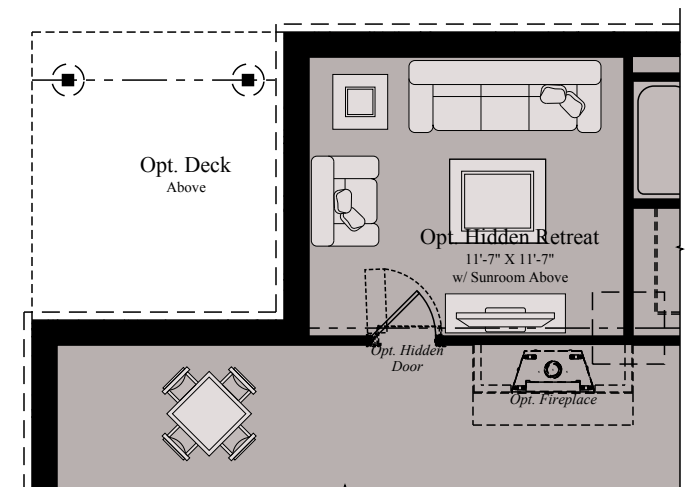
